

Barclays Cashback Rewards 1% Debit Card Spend Offer 2024

Terms and Conditions

As part of Barclays Cashback Rewards you will be eligible to earn 1% cashback on every transaction you make with a monthly cap of £5 using your eligible Visa debit card(s). This is in addition to any cashback you earn from retailer offers available through Barclays Cashback Rewards during the Offer Period.

This Offer will commence on **00:00 on 4th September 2024 and end on 23:59 on 30 November 2024** (Offer Period). We reserve the right to withdraw, amend or replace this Offer at any time during the Offer Period.

You can earn an additional maximum monthly cashback reward of £5 during the Offer Period. Cashback will be applied to your Barclays Cashback Rewards account for relevant spend throughout the Offer Period, up to a maximum of £15 across the Offer Period.

You will be **eligible** for this Offer if you meet the following conditions throughout the Offer Period:

- You are an existing Blue Rewards member or Premier Banking customer and are registered for Barclays Cashback Rewards
- You have an eligible Barclays Visa debit card
- You are aged 18 or over and a UK resident.

You can check if your Visa debit card is eligible for cashback by viewing your linked cards in 'Settings' on your Cashback Rewards account.

The Cashback Offer

- During the Offer Period, 1% cashback can be earned on each eligible debit card transaction using your eligible Barclays Visa debit card(s), up to a total cashback value of £5 per calendar month. Following this, any further debit card transactions will not be eligible for additional cashback as part of this Offer (but will accrue cashback through any retailer offers available).
- The cashback payment of 1% per eligible debit card transaction (up to a total cashback value of £5 per month) will be made to your Barclays Cashback Rewards account, accessed from the Barclays App.
- The cashback payment will appear on your Barclays Cashback Rewards account in the statement section as 'Barclays Spend Reward'.
- The cashback payment will move to "Available cashback" as soon as you reach the total monthly cashback value of £5, or on the 5th of the following month if you have earned cashback below the value of £5.
